October? Snow on the peaks? Cooler mornings? I think it is time to think snow! But before we get ahead of ourselves. We should really talk trailers. Trailer maintenance in particular. I have grease fittings(zerks) on the spindles of my trailer. I have always greased them before every season. Last year when I got to the trail head. I noticed one of my white wheels was covered in grease and the grease cap was missing. Yup, I smoked a spindle. Turns out the grease I pumped into my zerk, pushed the seal out the back and my grease never got to the outer bearing. Now I pull the wheels and hubs and hand pack my bearings before the season. Just something I do for peace of mind, before I spend the day getting stuck.

Tires? What them round black things that hold air? Ya, them things. Did you know tires have a date code on them? It is next to the DOT in the oval on one side of your tire. It has the week and year the tire was made. Most tires are only good for 7 to 10 years before they go pop! When they go pop, they make, what truckers call an alligator, they bite everything in the way, normally destroying a trailer fender, floor or your sled above it. So, check them date codes and save yourself a headache of changing a flat on the side of the road in a snow bank. Most importantly, damaging you sled. That would be a bad day if a tire wrecked your sled, not your buddy.

Lights, the bright things on the sides and rear of your trailer, the ones that tell others you are turning or stopping. YUP, them be the ones. Check them, make sure they are working. Marker lights and tail, turn and stop. The trailer should be plugged into the truck to do this. ©

Now that your trailer is all ready to go, load the sled and head for the hills! Not Really! We will cover a few things next month to check on your machines before heading out. In the meantime, think snow! Happy Halloween.




